Explanation of Responses:

- Each Performance right represented a contingent right to receive a share of common stock based upon Trimble's financial performance. The Compensation Committee certified that the payout for this award would be 171.11% (out of a possible 200%) of the target to the reporting person based on the degree to which Trimble performed.
- These shares were retained by the Company in order to meet the tax withholding obligations of the award-holder in connection with the vesting of an installment of the restricted stock award. The amount retained by the Company was not in excess of the amount of the tax liability.
- A bona fide gift to Notre Dame High School that was made by the Reporting Person on March 05, 2019 and not previously reported.
- The amount of Securities Beneficially Owned has been adjusted to correct a mathematical error in calculating the total number of shares on the Form 4 filed on May 16, 2019.
